THEREFORE, BE IT RESOLVED that the Board of Trustees of the Louis Riel School Division ENACTS the ward boundaries which boundaries are depicted on the attached plan of the Louis Riel School Division and designated as Schedule A:

- 1. THAT the ward boundaries set out in this by-law become effective with the civic election to be held in OCTOBER 2006, and
- THAT the property bounded by the following be designated as Ward 1: Comprising an area bounded as follows: commencing at the intersection of the Red River & the northerly projection of Elmwood Rd; thence southeasterly along the centre line of Elmwood Rd & its projection to Thomas Ave; continuing southeasterly along the centre line of Thomas Ave and its projection to Panet Rd; thence southwesterly along the centre line of Panet Rd. to Mission St; thence southeasterly along the centre line of Mission St and its projection to Dugald Rd; thence easterly along the centre line of Dugald Rd to the west limit of part lot 162, plan 433; thence southerly and easterly along the said lot to the east limit of lot 162 ½, plan 433; thence southerly along the said east limit to the south limit of said lot 162 ½; continuing easterly along the said south limit to Plessis Rd.; thence southerly along the centre line of Plessis Rd. to Fermor Ave; thence westerly along the centre line of Fermor Ave to Lagimodiere Blvd.; thence northerly, westerly, north westerly & northerly along the centre line of Lagimodiere Blvd. to the northeasterly projection of the south limit of 45 Vincent Massey Blvd; thence south westerly along the said northeasterly projection and the south limit of 45 Vincent Massey Blvd. to Vincent Massey Blvd; thence northwesterly, southwesterly & southerly along the centre line of Vincent Massey Blvd. to Betournay St; thence westerly along the centre line of Betournay St. to Speers Rd; thence southerly along the centre line of Speers Rd to Winakwa Rd; thence westerly along the centre line of Winakwa Rd to Harper Ave; thence northerly along the centre line of Harper Ave to Betournay St; thence westerly along the centre line of Betournay St to Autumnwood Dr; thence southerly along the centre

line of Autumnwood Dr. to Cottonwood Rd; thence westerly along the centre line of Cottonwood Rd. to the CPR Emerson Subdivision; thence north westerly along the centre line of the CPR Emerson Subdivision to the south limit of the Windsor Park Golf Course; thence westerly along the said south limit to the Seine River; thence northerly along the centre line of the Seine River to the south limit of 107 Egerton Rd; thence southwesterly along the said south limit to Harrowby Ave; continuing southwesterly along the centre line of Harrowby Ave. to Des Meurons St.; thence southeasterly along the centre line of Des Meurons St. to Stranmillis Ave; thence southwesterly along the centre line of Stranmillis Ave. to St Anne's Rd; thence northwesterly along the centre line of St. Anne's Rd to St Mary's Rd; thence southerly along the centre line of St Mary's Rd to the south limit of 600 St Mary's Rd; thence southwesterly along the said south limit & its southwesterly projection to the Red River; thence westerly, northerly, easterly & northerly along the centre line of the Red River to the point of commencement.

- 3. THAT the property bounded by the following be designated as Ward 2: Comprising an area bounded as follows: commencing at the intersection of the Seine River and the northeasterly projection of the south limit of 107 Egerton Rd; thence southeasterly along the centre line of the Seine River to Bishop Grandin Blvd.; thence southwesterly along the centre line of Bishop Grandin Blvd. to the Red River; thence northwesterly, easterly, westerly, easterly, northerly, northeasterly, and northerly along the centre line of the Red River to the southwesterly projection of the south limit of 600 St Mary's Rd; thence northeasterly along the said south limit to St Mary's Rd; thence northeasterly along the centre line of St Mary's Rd to St Anne's Rd; thence southeasterly along the centre line of St Anne's Rd to Stranmillis Ave; thence northeasterly along the centre line of Stranmillis Ave to Des Meurons St; thence northwesterly along the centre line of Des Meurons St. to Harrowby Ave; thence northeasterly along the centre line of Harrowby Ave and its northeasterly projection to the point of commencement.
- 4. THAT the property bounded by the following be designated as Ward 3 Comprising an area bounded as follows: commencing at the intersection of the Red River and Bishop Grandin Blvd.; thence northeasterly along the centre line of Bishop Grandin Blvd. to the Seine River; thence southeasterly along the centre line of the Seine River to the south end of Willowgrove Rd; thence southerly along the southerly projection of Willowgrove Rd to Four Mile Rd; thence easterly and southerly along the centre line of Four Mile Rd to the northeasterly projection of Two Mile Rd; thence southerly along the centre line of Two Mile Rd. to the northeasterly projection of 4185 St Mary's Rd; thence southwesterly along the said northeasterly projection to the Red River; thence northerly, westerly, northerly, easterly, northerly, southerly, northwesterly, southeasterly, westerly & northerly along the centre line of the Red River to the point of commencement.
- 5. THAT the property bounded by the following be designated as Ward 4.
