# SUPERINTENDENT'S REPORTS RIEL Project Update

Mr. Borys, Superintendent of Schools & CEO, provided the Board of Trustees with his recommendations pertaining to the School Review Processes conducted during the 2007-08 school year. Furthermore, he recommended that the students of École Henri-Bergeron be amalgamated with the students of École Provencher in September 2009 and that the students of Archwood School and Marion School be amalgamated at École Henri-Bergeron in September 2009. Finally, he recommended that the families of students attending Dr. D. W. Penner School in June 2009 be permitted "schools of choice" options at Darwin School, George Mc Dowell School, Minnetonka School, or Samuel Burland School for September 2009 (including their pre-school siblings) for September 2009 and that the catchment for the current Dr. D. W. Penner School be

included in the catchment for Victor H. L. Wyatt School effective September 2009 for any new students.
