WHEREAS it is required that the ward boundaries be established in compliance with Section 57 of the Public Schools Act,

THEREFORE, BE IT RESOLVED that the Board of Trustees of the Louis Riel School Division ENACTS the ward boundaries which boundaries are depicted on the attached plan of the Louis Riel School Division and designated as Schedule A: 1. THAT the ward boundaries set out in this by-law become effective with the civic election to be held in OCTOBER 2006, and

2. Comprising an area bounded as follows: commencing at the intersection of CPR Emerson Subdivision & Cottonwood Rd; thence northeasterly along the centre line of Cottonwood Rd to Autumnwood Dr; thence northerly along the centre line of Autumnwood Dr. to Betournay St; thence easterly along the centre line of Betournay St to Harper Ave; thence southerly along the centre line of Harper Ave. to Winakwa Rd; thence easterly along the centre line of Winakwa Rd to Speers Rd; thence northerly along the centre line of Speers Rd to Betournay St; thence easterly along the centre line of Betournay St to Vincent Massey Blvd.; thence northerly, northeasterly and southeasterly and along the centre line of Vincent Massey Blvd. to the south limit of 45 Vincent Massey Blvd.; thence northeasterly along the said south limit to Lagimodiere Blvd.; thence southerly, southeasterly & southerly along the centre line of Lagimodiere Blvd. to Fermor Ave; thence easterly along the centre line of Fermor Ave to Plessis Rd; thence southerly along the centre line of Plessis Rd and its southerly projection to the south limit of Riel Community Committee Area; thence westerly & southwesterly along the said south limit to the south end of Willowgrove Rd; continuing southwesterly to the Seine River; thence northwesterly along the centre line of the Seine River to the rear lot line of the houses facing south on Iroquois Bay; thence northeasterly & easterly along the said rear lot line of the houses facing south on Pawnee Bay; continuing easterly along the said rear lot line to the rear lot line of the houses
