- d) That the agreement designates the City of Winnipeg as the business agent and formal contact to administer the Joint Use Agreement, for its duration;
- e) That the City of Winnipeg maintain responsibility for attending to communications, emergency preparedness planning, and health and safety requirements, of any community programs operating during their allotted times, as required by the Fire Department and the Workplace Safety & Health Act.

(Please note that the Division's requirement for the City to assume responsibility for emergency preparedness and health and safety relates directly to requirements of the Fire Department and the Workplace Safety & Health Act.)."
