establishment of a reserve of \$90,000 for a Microsoft SharePoint Upgrade; and the establishment of a reserve of \$80,000 for the installation of projectors in gymnasiums at various schools; and,

- Charlene Sacher: I am amazed at the hard work that has gone into RDC, I a wondering if there has been any consideration in terms of the French Immersion schools that are really impacted. We are looking for are looking for ways to extend support to as many people as possible, but starting with that core group.
- Lawrie Good: Has there been more discussion regarding the Active Transportation Report? Acting
 Assistant Superintendent, Henri Peloquin, is leading this initiative along with Business Manager,
 Amarbeer and the Transportation Department, which now includes 15 administrators joining this
 conversation. The City of Winnipeg, MPI, Green Action Committee, Police, a Traffic Management
 consultant are also involved in this report. The target date to present the final report is June 5th,
