It comes as a result of a student-led initiative, and I acknowledge the efforts of J. H. Bruns Collegiate students Nika Martinussen, Kelsey McLeod, and Lianne Adair. Their vision is of a sustained and mutually supportive relationship between these two communities in the spirit of Reconciliation, and if today is any indication, things are off to a great start."

"Windsor Park Collegiate played host to grade 5-8 students today, supported by the Technology Educators Association of Manitoba. Trustee Parker and I watched them engage in activities designed to spark interest in technology and industrial arts including the use of virtual reality, graphic design, and robotics."
