3.1 News from the Board of Trustees Provided by Trustee Parker

In the lead-up to National Day for Truth and Reconciliation, LRSD schools invested time in conversation with students and community. While out in the community on Sept. 30, I noticed many people wearing orange shirts.

Students at École Guyot marked the day with a series of installations that included orange dreamcatchers, shirts and knit works, and the school was featured in a CBC report.

I am proud of the work that is being done in our schools as we journey on the path of truth and toward reconciliation.

All schools in Ward 4 have their Parent Advisory Councils (PAC groups) up and running and I look forward to hearing more about their plans for the year.

3.2 News from Superintendent Michalik

- In LRSD and across Canada, we recognized Truth and Reconciliation Week from Sept. 27 to Oct. 1. During which time, we reflected on the history and legacy of residential schools in various ways. It was an emotional week of learning for all of us, which was made possible by our Indigenous Education Team, who put together a journey for us as a school division and provided critical supports along the way.
- The National Day of Action for Murdered Indigenous Women, Girls and Two-Spirit People (MMIWG2S) was held on Oct. 4, which provided another opportunity for us as a community in LRSD, and in Manitoba, to reflect. The Indigenous Education Team put together supports, tools, and materials to assist us on this journey of self and collective reflection.
- Today, Oct. 5, is the United Nations World Teachers' Day and it is important to
 observe. I am so grateful to the teachers in LRSD for their incredible leadership and
 resilience throughout the pandemic, and I am counting on them to continue to
 display similar strength leadership and courage in the weeks ahead, because the
 pandemic is still ongoing.
- I want to acknowledge the LRSD Communications Team, which is led by Taylor Fenn and supported by Lexi Muise. Our division is keeping things simple by sharing our stories and lived experiences; nonetheless, this tiny but mighty team generates a lot of high-quality work. It is nice to be recognized by an organization dedicated to promoting and supporting communications in Canada.
