the homeland of the Métis. We recognize that Manitoba is also the traditional land of the Anishininwak and Dene.

We respect the treaties made on this land and acknowledge the harms and mistakes of the past and present. We dedicate ourselves to authentic alliances with Indigenous communities in a spirit of reconciliation and cooperation.

The ongoing development of LRSD's land acknowledgement is guided by our Indigenous Council of Grandmothers and Grandfathers, and we thank them for their generosity and collaboration.

10.2 Program Designation of Second Elementary School in Sage Creek

THAT having received the Superintendent's report and recommendation to address enrolment challenges in the southeast quadrant of the school division as information, and;

THAT the following motion be adopted:

WHEREAS École Sage Creek School does not have sufficient capacity to accommodate all Kindergarten to Grade 8 students from both the English program and the French Immersion program, and;

WHEREAS the Louis Riel School Board and its divisional administration have consulted government officials and community members regarding the need for a second elementary school in Sage Creek with a proposed capacity of 850 students, and;

WHEREAS the provincial government authorized land acquisition for said school in December 2020 and the Louis Riel School Board purchased 7.22 acres of land for said school in May 2021, and;

WHEREAS the Louis Riel School Board currently awaits an announcement from the provincial government authorizing the design and construction of said school, and;

WHEREAS current enrolment data indicate that, year over year, a greater number of Sage Creek families are choosing the French Immersion program for their children, and;

WHEREAS the Louis Riel School Division is experiencing overcrowding and unsustainable growth at École Van Belleghem related to the Bonavista residential development, and;

WHEREAS the Louis Riel School Board and its divisional administration have reviewed current and historic enrolments, enrolment projections, school capacities, and planning scenarios to address this specific challenge, and;

WHEREAS the Louis Riel School Board and its divisional administration have engaged the Windsor Park Collegiate, J. H. Bruns Collegiate and Collège Béliveau Families of Schools in a series of meetings, from March to May 2022, related to historic and future demographic changes in the southeast quadrant of the school division, and;

WHEREAS this consultation process has provided an opportunity for the community to review the results of our research, analysis, and criteria and to provide invaluable perspectives to inform the objective of developing an achievable long-term solution to address current and projected enrolment challenges:

THEREFORE BE IT RESOLVED:

- THAT the Board designate the existing building at 315 Sage Creek Boulevard to serve Kindergarten to Grade 8 English program students residing in Sage Creek once a second LRSD elementary school opens its doors in the community; and,
- THAT the Board designate the second elementary school, situated at the southeast corner of the western intersection of Warde Avenue and Robert Bockstael Drive, to serve Kindergarten to Grade 8 French Immersion program students residing in Sage Creek and Bonavista; and,
- THAT, once a second LRSD elementary school opens its doors in Sage Creek, parents
 of students residing in Bonavista and registered at École Van Belleghem be given
 the option to have their child complete their elementary schooling at École Van
 Belleghem or to enrol at the new school.
