# 3.1 News from the Board of Trustees Provided by Trustee Parker

Trustee Parker highlighted the following:

- All schools were involved in activities related to Truth and Reconciliation Week.
   The range of activities included classroom discussions to school events.
  - St. George School focused on "Every Child Matters," and the negative impact of residential schools.
  - Hastings School had an official opening of their Indigenous Garden,
     Mashkiki Aki which translates to "Medicine Earth." It is a garden that will

include sage and cedar, as well as 215 orange tulips. It will be a place to reflect and learn.

- Congratulations to Mark Lesiuk, teacher at Highbury School, and Chris
  Heidebrecht, teacher at Minnetonka School, who received the Prime Minister's
  Certificate of Achievement in Science, Technology, Engineering and
  Mathematics (STEM) to recognize their work on Manito Ahbee Aki.
- Windsor School is celebrating 100 years during this school year.
- At Minnetonka School, students created puppets dressed in Jets jerseys to cheer on the Winnipeg Jets.
- École Van Belleghem held their community/school barbeque on September 29.
- The Leadership Team will engage in professional development on Oct. 11 and 12 at the Canadian Museum for Human Rights. Trustees will be in attendance to begin the day of learning on Oct. 11.

- The LRSD Indigenous Education Team launched the first annual Film Festival on Sept. 26.
- LRSD is still promoting the Who Are We? campaign. To be more diverse, equitable, and inclusive, we need to measure the progress made with the Diversity, Equity, and Inclusion initiative, and some of the baseline data is still missing. We are re-engaging the community in order to foster relationships and trust, and to encourage everyone to declare their child(ren)'s ancestral and cultural identities.

#### 7. INFORMATION TO THE BOARD

## 7.1 New School Update - École Sage Creek & Bonavista

Superintendent Michalik shared an update regarding the construction of the new school that will support students enrolled in the French Immersion program, who live in Sage Creek and Bonavista. The Province of Manitoba has issued a Request for Proposals (RFP) for the design of a kindergarten through grade 8 French Immersion school that will open by September 2025. This school would serve 900 students from the Sage Creek and Bonavista areas. The deadline for RFP submissions is Nov. 1 and the ranking and communication of results is anticipated on Nov. 18.

# 7.2 Collège Jeanne-Sauvé Renovation and Addition Update

Assistant Superintendent Anderson shared an update regarding the renovation and addition at Collège Jeanne-Sauvé and advised that the project is on schedule.

## 7.3 J.H. Bruns Collegiate Renovation and Addition Update

Superintendent Michalik shared that this evening, Assistant Superintendent Murray is meeting with the J.H. Bruns Collegiate Parent Advisory Council to inform them we are working with the architects on a number of design options for the addition, with the goal of having one Class D (conceptual) design concept. The plan is to bring the architects and the community together on Oct. 20 and again in December. By the end of December, we hope to have one Class D (conceptual) design for the major addition at J.H. Bruns Collegiate.

# 7.4 Windsor Park Collegiate Renovation Update

Superintendent Michalik shared that Assistant Superintendent Murray has been speaking with Robbie Mager, Principal, Windsor Park Collegiate, about how we can come together as a community to collaborate with an architect to design the spaces at Collège Béliveau for the Windsor Park Collegiate community. In preparation, Robbie Mager and Andrea Kolody, Principal, Collège Béliveau, have been meeting frequently and visiting spaces, and will be meeting with staff, students, and families.

## 7.5 Collège Béliveau Renovation Update

## 7.6 Marion School Renovation and Addition Update

Superintendent Michalik shared that the Province of Manitoba has issued a Request for Proposals (RFP) for the design of the Marion School major addition. We anticipate having a consultant to design the addition.

# 7.7 École Varennes Update

Superintendent Michalik and Assistant Superintendent Anderson shared an update regarding École Varennes and the need to build a new school to replace the existing school. Architects and engineers will co-design a new two- or three-story building while keeping students in the existing school during the process. Once a new school is ready, we will tear down the old school which will become the playground.

Superintendent Michalik shared perspectives from principals and vice-principals regarding the many successes relative to the current MYSP; identifying strengths and areas of improvement.
