### 1.1 LRSD Land Acknowledgement

• Trustees Gerrior, Champagne and I, along with members of the Senior Leadership Team (SLT) took a tour of Darwin School, where we saw and heard about the

expanded classrooms, industrial arts, and other excellent programming. We were also updated about renovations planned for the gymnasium.

- A fantastic breakfast hosted by Collège Béliveau on Friday, Feb. 17, 2023, was one of many events taking place across the division to celebrate Festival du Voyageur.
- On Feb. 6, Trustee Nemeth and I along with members of the SLT attended an excellent presentation from HTFC Planning & Design held at École Sage Creek School, outlining the plans for the construction of the new school that will support students enrolled in the French Immersion program who live in Sage Creek and Bonavista.
- Trustee Nordheim and Glenlawn 100 Steering Committee were featured in a Community Review East article published on Feb. 8, 2023.
- On Feb. 24, Dr. D.W. Penner School Parent Advisory Council (PAC) will be hosting another family movie night.
- Feb. 15 was International Angelman Day, which is a day to raise awareness about a rare genetic condition. My heart was warmed seeing the angel-decorated classroom at Glenwood School as they showed support for their angel classmate.
- February marks Black History Month and many LRSD schools are hosting events and teaching moments, learning about the history and accomplishments of black Canadians, including two of our division's three first ever black members of the legislative assembly, MLA Audrey Gordon and MLA Jamie Moses.

# 3.2 News from Senior Leadership (SLT) Team Provided by Assistant Superintendent Murray

Assistant Superintendent Muray provided the following highlights:

- On Jan. 16 and 17, Windsor Park Collegiate took 85 students ice fishing at the Lockport Ice Fishing Village. The trip was organized by the Grade 10 Geography Teaching Team and supported by the Indigenous Education Team.

- Niakwa Place School is celebrating the arrival of the Kitchen Brigades. This is a subsidized 24-week food literacy program.
