the homeland of the Red River Métis. We recognize that Manitoba is also the traditional land of the Anishininwak and Dene.

We respect the treaties made on this land and acknowledge the harms and mistakes of the past and present. We dedicate ourselves to authentic alliances with Indigenous communities in a spirit of reconciliation and cooperation.

The ongoing development of LRSD's land acknowledgement is guided by our Indigenous Council of Grandmothers and Grandfathers, and we thank them for their generosity and collaboration.

- J.H. Bruns Collegiate Guitar Band received the CBC Music Award and was recognized at the legislature.
- Collège Jeanne-Sauvé Musical performance of *The Addams Family* was a huge success with over 2,000 people enjoying the performances.

I want to acknowledge the culture and atmosphere of excellence that we maintain in all of our schools in LRSD. The staff, students and volunteers are to be commended for their commitment.

3.2 News from Senior Leadership (SLT) Team Provided by Assistant Superintendent Murray

Assistant Superintendent Murray provided the following highlights:

- Students and staff at General Vanier School acknowledged Down Syndrome Day on March 21 with a special assembly featuring special guest, Liam Frain. Liam, 24, is a General Vanier School alumnus who appeared in the made-in-Manitoba film *Champions*, starring Woody Harrelson. The special assembly was organized by Sabrina and Amadora, Grade 5 and 6 students, who stated, "A big part of World Down Syndrome Day is about embracing all-inclusivity and celebrating everyone's own unique self."
- Ridhwanlai Badmos, a Grade 12 student at Windsor Park Collegiate, was named a 2023 Loran Scholar. The Loran Award is given to young people based on their character, commitment to community service, and leadership potential.
- Despite the Windsor Park Collegiate hockey program only forming two years ago, they were able to win the 2023 Winnipeg High School Hockey League's Price Division championship.

9. SENIOR LEADERSHIP TEAM INFORMATION TO THE BOARD

9.1 New School Update - École Sage Creek & Bonavista

Superintendent Michalik and Assistant Superintendent Anderson shared an update regarding the construction of the new school that will support students enrolled in the French Immersion program, who live in Sage Creek and Bonavista.

- Members of the SLT, along with officials from the province and Number Ten Architectural Group (NTAG) reviewed applications for the Construction Manager RFP. The selection process has occurred, and a public announcement is forthcoming.
- Next week, meetings will take place to review room specifications for all the various types of learning spaces in the new school. The architectural team will

hear directly from teachers, administration and members of the School and Classroom Support Team and will tweak designs accordingly.

9.2 Collège Jeanne-Sauvé Renovation and Addition Update

Superintendent Michalik and Assistant Superintendent Anderson shared an update regarding the renovation and addition at Collège Jeanne-Sauvé.

- Science wing with five classrooms:
 - o Furniture has arrived and has been set up.
 - o Inspections have been completed.
 - Teachers started to prepare the classrooms for students to return to these spaces on Thursday.

• Addition:

- o The exterior structure (brick and steel) is progressing well.
- The music room will be closed to the elements in the upcoming weeks.
- Installation of roof trusses is currently ongoing.

9.3 École Varennes Update

Superintendent Michalik and Assistant Superintendent Anderson shared an update regarding École Varennes and the need to build a new school to replace the existing school. There is not much to update; however, to address Trustee Palmquist's question about how many three-storey schools exist, I can confirm that Regina, Saskatchewan has one three-storey K-8 school, details of which can be provided upon request.

9.4 Collège Béliveau Renovation Update

Superintendent Michalik and Assistant Superintendent Anderson shared an update regarding the renovation at Collège Béliveau and Windsor Park Collegiate. Members of the SLT will be preparing a formal request for assistance to supplement previous information submitted to the province.

- We will be providing clarity to the project manager regarding the concept design for the addition which was submitted to the province.
