1.1 LRSD Land Acknowledgement

homeland of the Red River Métis. We recognize that Manitoba is also the traditional land of the Anishininwak and Dene.

We respect the treaties made on this land and acknowledge the harms and mistakes of the past and present. We dedicate ourselves to authentic alliances with Indigenous communities in a spirit of reconciliation and cooperation.

The ongoing development of LRSD's land acknowledgement is guided by our Indigenous Council of Grandmothers and Grandfathers, and we thank them for their generosity and collaboration.

9. INFORMATION FROM THE BOARD

9.1 Glenlawn Collegiate Institute 100th Anniversary Reunion Report

Trustee Nordheim provided a report regarding the Glenlawn Collegiate Institute 100th Anniversary Reunion celebrated May 19 to 21, 2023. She acknowledged all the organizers, with special thanks to Wayne Ruff and Tom McCormack, and all participants

for this very successful event. A detailed report was provided by the organizing committee.

The Chair thanked Trustee Nordheim for her efforts supporting this event.

10. SENIOR LEADERSHIP TEAM INFORMATION TO THE BOARD

10.1 New School Update - École Sage Creek & Bonavista

Assistant Superintendent Anderson shared an update regarding the construction of the new school that will support students enrolled in the French Immersion program, who live in Sage Creek and Bonavista. The 33 per cent design reviews have been completed and the 66 per cent design development has started. In response to Trustee Palmquist's question regarding the enrolment breakdown, we are forecasting about 80 per cent of students will attend the school residing in the Sage Creek area and the remaining 20 per cent from the Bonavista area. At full capacity, that would be 720 from Sage Creek and 180 from Bonavista.

10.2 Collège Jeanne-Sauvé Renovation and Addition Update

Assistant Superintendent Anderson shared an update regarding the renovation and addition at Collège Jeanne-Sauvé.

- The roof deck and parapets are being installed on the west half of the building
- The roof installation is complete on the music room
- Second floor structural masonry is completed on the east half
- Electrical, plumbing, hydronics and control rough-ins are in progress
- Stainless steel stud framing on the main floor continues

The project is currently on schedule, and we anticipate partial occupancy in September.

10.3 Accessibility Plan Updates

Superintendent Michalik provided feedback received from the Accessibility Community Consultation held on May 3, 2023, facilitated by Assistant Superintendent Cormack. There were 43 participants, 20 who attended virtually. A student, parent, and staff member shared their lived experiences with respect to accessibility in LRSD and there were group discussions regarding the impact of current supports and barriers. This journey will continue which will inform and guide the accessibility plan.

10.5 Air Conditioning Update

Superintendent Michalik shared an update regarding the plan for air conditioning in the division as part of the Multi-Year Strategic Plan (MYSP) for 2023-2027 and strategic action 4.1 focused on ensuring that the built learning and working environments are safe, accessible, and equitable. The temperatures in 11 schools and at the Maginot Shop in the summer months are an inequity that needs to be addressed.
